New Brunswick Moved to Level 3,

New Brunswick moved to Level 3 of the COVID-19 winter plan, the most restrictive level, effective Friday, Jan. 14 at 11:59 p.m. This decision is to help protect the health care system and those who work in it. The lockdown will last until Jan. 30 at 11:59 p.m. Under Level 3, faith services are allowed only outdoors or virtually.

The Anglican Parish of Woodstock will be providing **on-line services only, for Jan. 23 & Jan. 30, 2022**. The service for Jan. 23 will be livestreamed to Facebook at 10:30 am and available anytime afterwards for viewing. The service for Jan. 30 will be prerecorded and available for viewing anytime after 9 am that day. We hope to resume in-person worship beginning Feb. 6, 2022.
